






- A) THE FIRST PARTY is a Government-Aided Higher Educational Institutional Named:  
ASANSOL GIRLS' COLLEGE, Dr Anjali Roy Sarani, Asansol, Paschim  
Bardhaman, Pin-713304.
- B) THE First Party and Second Party believe that collaboration and cooperation between  
themselves will promote more effective use of each other's resources, and provide  
each of them with enhanced opportunities.
- C) The parties intend to cooperate and focus their efforts in cooperation within the area  
of Higher Education, Research and Development, provide opportunity for global  
experience, and to facilitate advancement of knowledge on the basis of reciprocity,  
best effort, mutual benefit, and frequent interactions.
- D) Both Parties being legal entities in themselves desire to sign this MoU for advancing  
their mutual interests.
- E) The Indian Institute of Technology (Indian School of Mines) constituted under  
Institute of Technology Act, 1961 is administered through IIT Council-the apex body,  
Government of India under the Chairmanship of Honourable Minister, MoE for  
uniform and smooth governance of Pan-IIT in our country, is the second party.


NOW THEREFORE , IN CONSIDERATION OF THE MUTUAL PROMISE SET  
FORTH IN THIS MoU. THE PARTIES AGREE AS FOLLOWS:

Clause-I  
COOPERATION

- 1.1. Both the Parties are united by common interest and objectives and they shall establish  
channels of communication and cooperation that will promote and advance to the best  
efforts and as far as practicable-
- a) Faculties of the Asansol Girls' College to engage as researcher (Part time) in IIT (ISM)
  - b) Faculties of the Asansol Girls' College to engage as research co-guide with the  
Principal guide of IIT(ISM)
  - c) Joint research projects/publications to be pursued.
  - d) Departments to exchange students for the internship programs included under NEP



- e) Faculty and student exchange based on reciprocity, e.g. collaborative NSS programs, collaborative gender sensitisation programs to be organised.
  - f) Team taught courses (including online courses).
  - g) Joint organisation of short-term continuing educational programs on topics of mutual interest and to invite each other's faculties to participate therein.
  - h) Collaborative seminars/workshops/conferences/academic enrichment programs on topics of mutual interest and to invite each other's faculty and students to participate therein.
  - i) Every activity resulting from this MoU is to be implemented via official communication from the Principal of the host Institution. Acknowledgement of the same is to be issued by the Principal of the host Institute to the Resource person after completion of the said program. Geo-tagged photographic record of each activity is to be properly documented by the Institute and handed over to the other counterpart.
  - j) Faculties of Parties 1 & 2 to be involved in Classes at each other's institutions for specific modules and in departments where the need has been ascertained by the institutional heads. These classes will be conducted in the Compact Module system where continuous classes will be scheduled in an arrangement for one or two weeks as per the requirements of the syllabus and the students.
  - k) The list provided above is not exhaustive and that other items or elements, not specifically mentioned may also be included.
- 1.2. Both the Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.3. The First Party and Second Party must respect each other's intellectual property and in case of disputes, if any relating to any aspects of academic cooperation. The Heads of both the Colleges will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.
- 1.4. Both the Parties mutually agree not to include any financial transaction during the execution of this MoU.
- 1.5. Neither Party shall be held responsible for non-fulfilment of their respective obligation under the MoU due to circumstances beyond their control but not limited to pandemic, war, flood etc. If such a condition continues beyond six months, the parties shall then mutually decide about the future course of action.
- 1.6. Nothing in this MoU shall be construed to make either party a partner, an agent or a legal representative of the other for any purpose. Now onwards both the parties may





mention the name and LOGO of the other in their documents as "COLLABORATOR" for purpose as may be required, subject to communication by the user to the other party in writing beforehand.

1.7. This MoU unless terminated by mutual written agreement will continue for 5 years after the effective date specified in the opening paragraph and can be renewed through mutual interest. Either party shall have the right to unilaterally terminate this MoU upon a ninety days prior written notice to the party.

1.8. The scope of this MoU is not restricted or limited to the list of items specifically mentioned above. Further areas of collaboration can be expanded in the future according to needs as they arise, as the above list is not exhaustive.
